

Conditions of Sales: *Rhino Steel Buildings*

Supply of *Rhino Steel Building Kits*

We will confirm acceptance (or otherwise) of your order as soon as possible, either by email (if your order is placed online) or by telephone (if your order is placed over the telephone). A binding agreement arises once we accept your order and invoice is raised, we will then charge a non refundable deposit. The date of delivery will not be given until contract final payment is paid in cleared funds. Approximately ten - fourteen days to delivery for building kit from factory. Export orders subject to shipping time scale. *Rhino Steel* will not be held responsible for any losses incurred by late delivery or project completion times not being met for what ever reason.

Payments

You can pay for your order by *Cheque Bacs. or Chaps*. We will take all reasonable care to keep your order details secure. If the billing address and delivery address do not match, a letter or email will be sent to the billing address. You will then need to respond to the letter before the goods can be despatched.

Please note: Any increase in the cost of raw materials during the manufacturing process for any reason out with our control, including extra parts to building kit required to meet structural engineering or to comply with local planning requirements that were not included in quotation for what ever reason may be charged at our discretion. Retention of title remains with *Rhino Steel buildings* until the supply of building kit and any other services provided are paid in full. It is the customers responsibility to insure building kit for its full value when delivery has taken place. *Rhino Steel* take no responsibility for any goods stolen or damaged on site.

Retention of title

For the avoidance of doubt the title of building kit and all services provided do not pass to the customer until all sums due are paid in cleared funds and a completion certificate is issued by *Rhino Steel*. Up to this time access to the building is restricted to Rhino authorised erection personnel only. Unless written authorisation is given by Rhino Steel for other trades to carry out tasks that do not interfere with erection team and conforms with health and safety, this is at the discretion of Rhino Steel buildings Project manager. It is a strict condition that building must not be used for any commercial purpose until official hand over and completion certificate is issued.

Cancellation and Returns Information

Any transit damage, shortages or incorrect goods supplied must be noted on the delivery note at the time of delivery. Please ensure that you thoroughly inspect your goods for any cosmetic damage, incorrect goods, missing parts or other problems as soon as you receive them. If this is done after delivery has taken place, you are

required to contact us within 7 days of delivery of your goods giving full details of any problems for us to arrange for suitable action to be taken. Damaged Goods

If you receive goods in a damaged condition, please make a note of this on the despatch note, you will need to notify us of this by phone, email or letter in any case within 7 days from receipt of goods. Please try and supply photographic images of damage by email to speed up the process.

Incorrect Goods/Wrong amount of Goods

It is your responsibility to ensure that you have signed for the correct number of goods delivered. At time of delivery you must also check that you have received the correct goods in accordance with your order by checking against bill of materials supplied. If you find that you have received incorrect goods or the wrong amount of goods, you must make a note of this on the despatch note. You must then notify us of this by phone, email or letter in any case within 7 days from receipt of goods.

Please note: Do not fit an item if it is damaged. This counts as acceptance of goods and the item is then non returnable.

Unwanted Items

You have the right to cancel your order at any time before goods are manufactured / delivered however it will result in loss of monies paid . We will try to resell through our web site or by other means to to limit losses , this could result in incurring further charges. In compliance with the distance selling regulations you have a "Cooling Off" period where you may withdraw from this agreement at any time up to 7 days after the day we have delivered the goods to you. If we have delivered the goods, you must not have used them and must have kept them in the condition they were delivered. You must return them to us, at your cost. Returned items after may be subject to 35% handling charge. When we receive the goods we will inspect them to ensure all manuals, accessories and other components are within the returned package and that the goods are in the condition that we sent them to you with packaging. All items are subject to inspection. If we receive an item that either is not in the condition we sent it or has missing components we shall deduct a reasonable amount to cover any costs to us or return them to you if they are not re-sellable.

Please note

We are unable to take back items that are bespoke/built to order.

Faulty Items

I.E. Doors or other options If after fitting a component you find that it is faulty, meaning your product shows symptoms of failure preventing basic operation (this does not include any superficial or cosmetic damages, for example scratches or dents), please contact us at your earliest convenience. We shall then arrange for an

approved engineer to visit you free of charge and offer you the following options; If repairable, the engineer will be able to carry out repairs on site or order parts and come back at your convenience to carry out the repair.

Replacement

We shall arrange for a replacement to be delivered to you at our expense and for the faulty item to be collected (usually at the same time). providing the component has been verified by the engineer as being faulty, we shall arrange for the component to be collected from your property and a full refund given. If we find that the item is not in its original packaging and has any accessories or components missing we shall carry out the refund and take out a fee to cover any costs.

Please note, any faulty items have to be seen by an authorised service engineer before any action can be taken. If your goods are not found to be faulty, a call-out charge may be incurred. If your item becomes faulty after having been fitted for more than 28 days, / please contact the Manufacturer directly to arrange a service call, this is part of the manufacturer's guarantee. (Gliderol doors 10 years .)

Complaints Procedure
